## 1. Incoming Reports

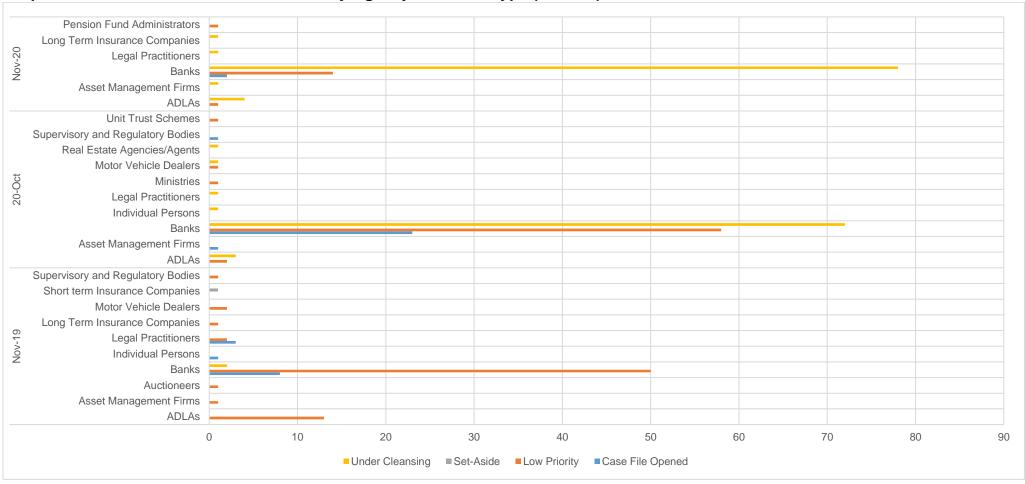

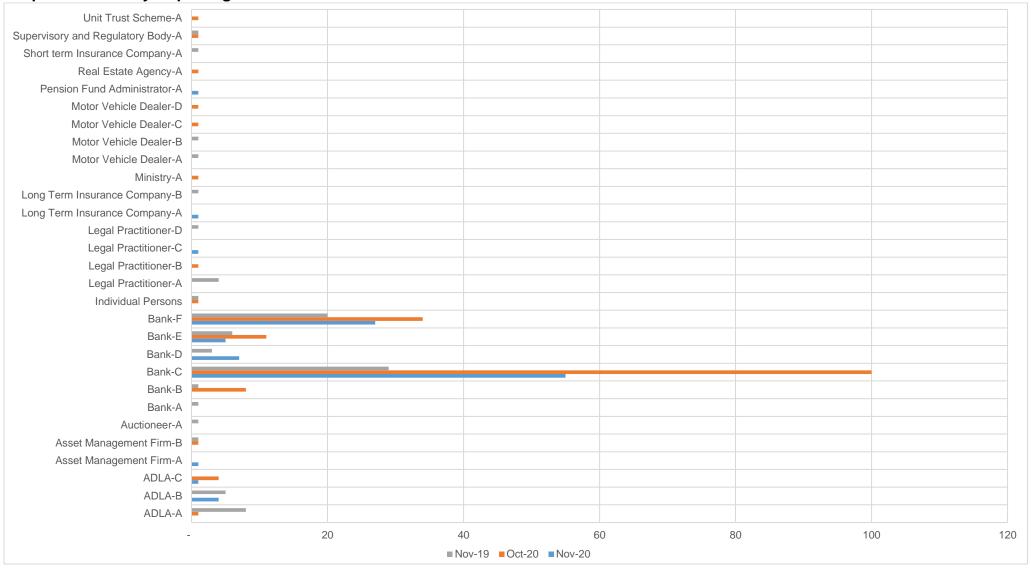
## 2. Classification of Reports

**Graph 2.1: Classification of STRs received by Agency Business Type (Sectors)** 



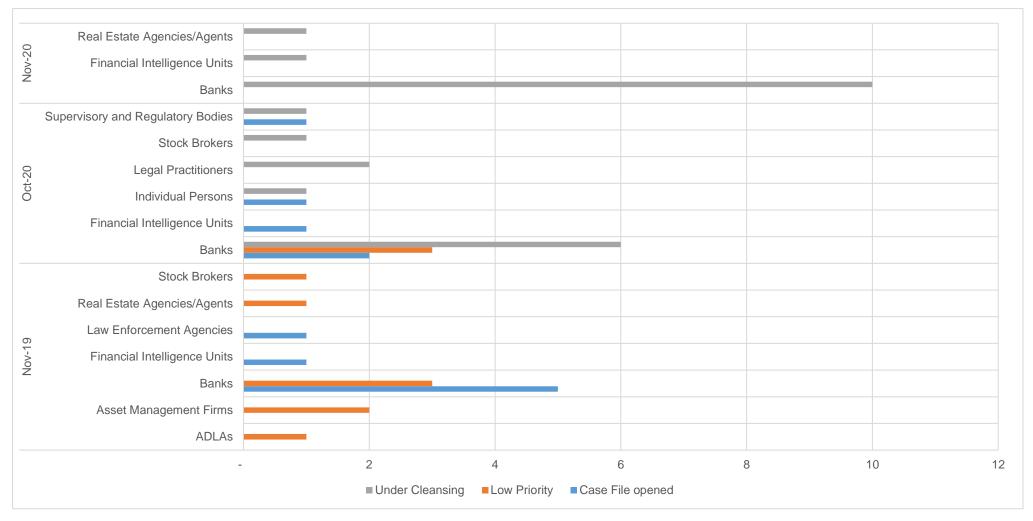
The chart above shows that the total number of STRs received during the period under review decreased significantly to 103 STRs when compared to 167 STRs recorded during October 2020. Further, from all the STRs received during the period under review, a total of 2 STRs were escalated for further analysis, whereas 16 were classified as 'low priority' and 85 of such reports were still under cleansing at the time of reporting. The banking sector continues to file the most STRs nationally.

**Graph 2.2: STRs by Reporting Entities** 



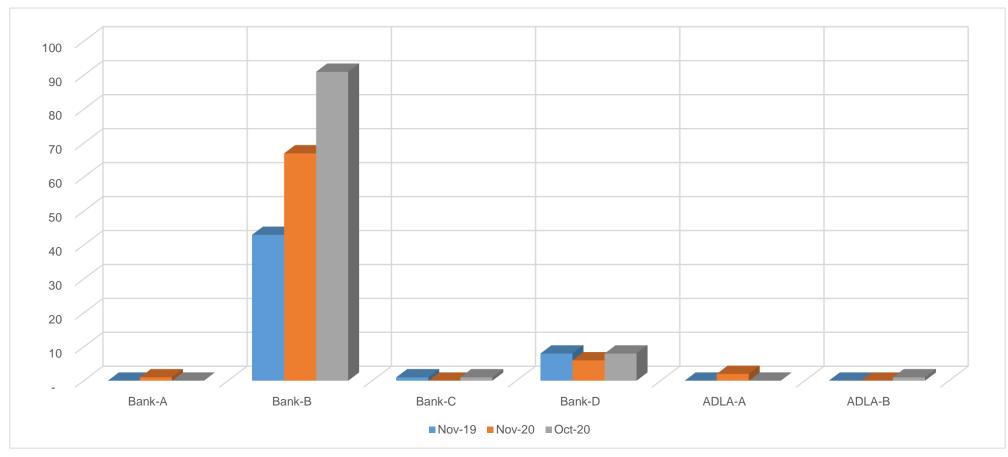
During the period under review, Bank-C filed the majority of STRs (55 STRs). This was followed by Bank-F with 27 STRs and then Bank-D filing a total of 5 STRs.

A total of 12 SARs were received by the FIC in November 2020. This is a slight decrease from 19 and 15 SARs received in October 2020 and November 2019, respectively. All the SARs received during the period under review were still under cleansing at the time of reporting.

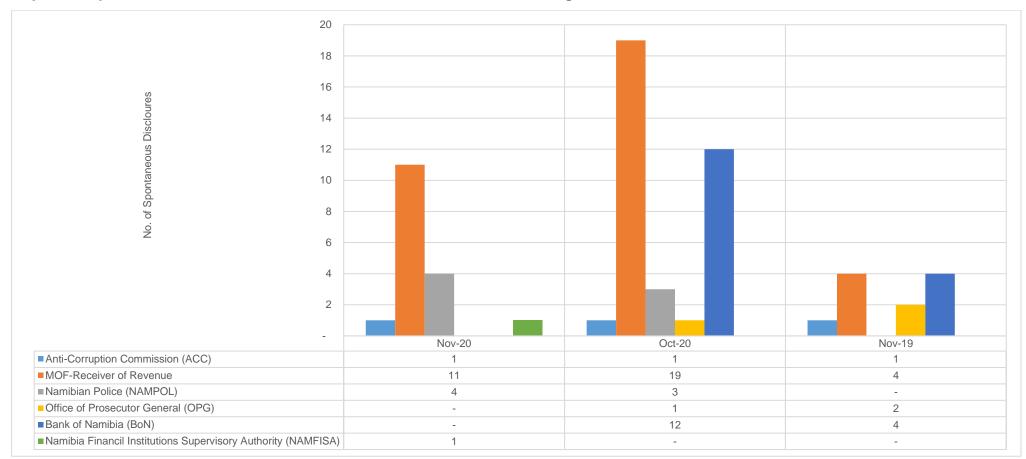

In the period under review, 321 Cases and 87 IRDs were still under analysis. Only 1 case was set aside during the period under review. A total of 113 STRs were classified as 'low priority', a significant decrease when compared to 261 STRs classified as such during October 2020. To date, the total number of SARs and STRs classified as 'low priority' amounts to 595 and 5,131 reports, respectively.

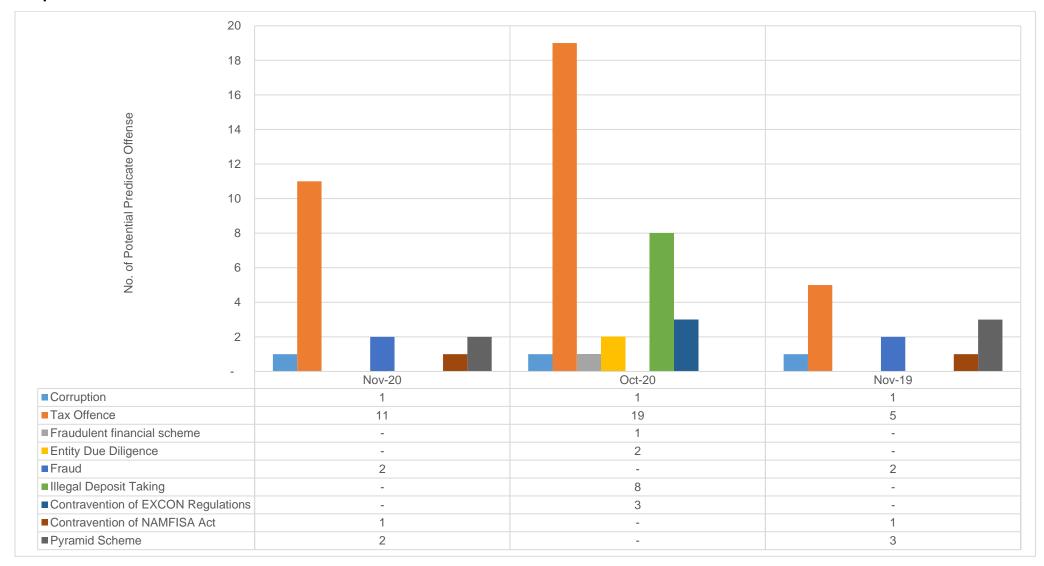
#### 4. Disclosures

In the period under review, the FIC disseminated 17 Spontaneous Disclosures (SDs) to Law Enforcement Agencies (LEAs). The Ministry of Finance- Receiver of Revenue received the majority of the disseminations (11 SDs), followed by the Namibian Police.

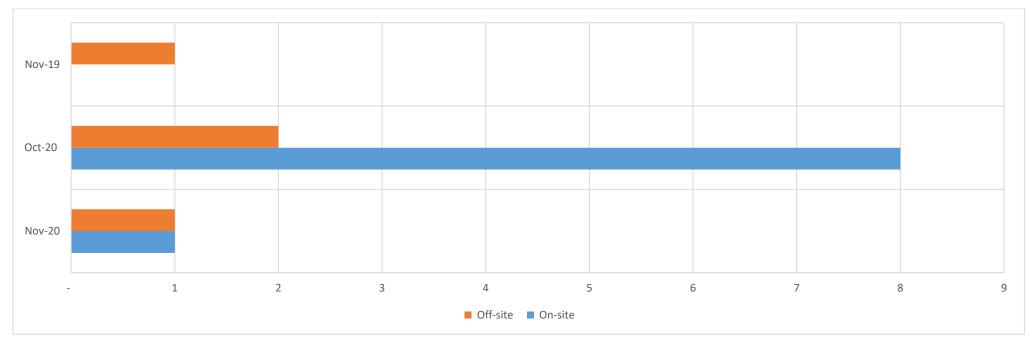

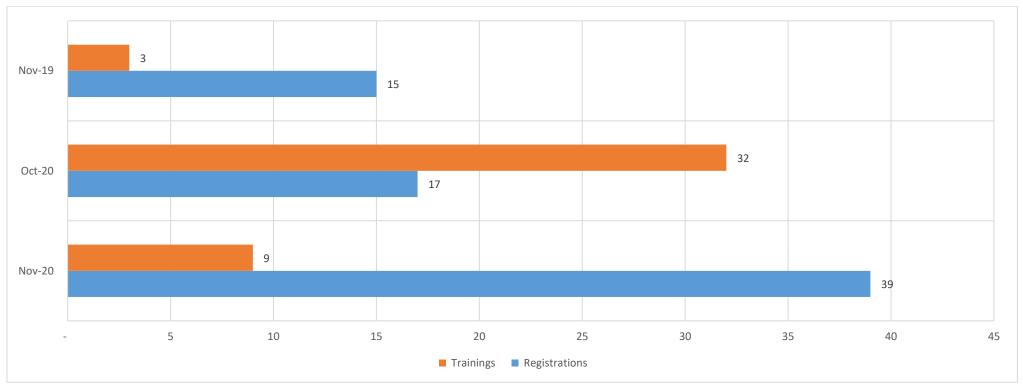
