



**Graph 2.1: Classification of STRs received by Agency Business Type (Sectors)** 




The chart above shows that the total number of STRs received during the period under review increased to 93 STRs when compared to 83 STRs recorded in February 2023. Further, from all the STRs received in the period under review, only 3 reports were classified as 'high priority' while 85 STRs were still under cleansing at the time of reporting. The banking sector continues to file the most STRs nationally.




In the period under review, Bank-G filed the majority of STRs (28 STRs).








