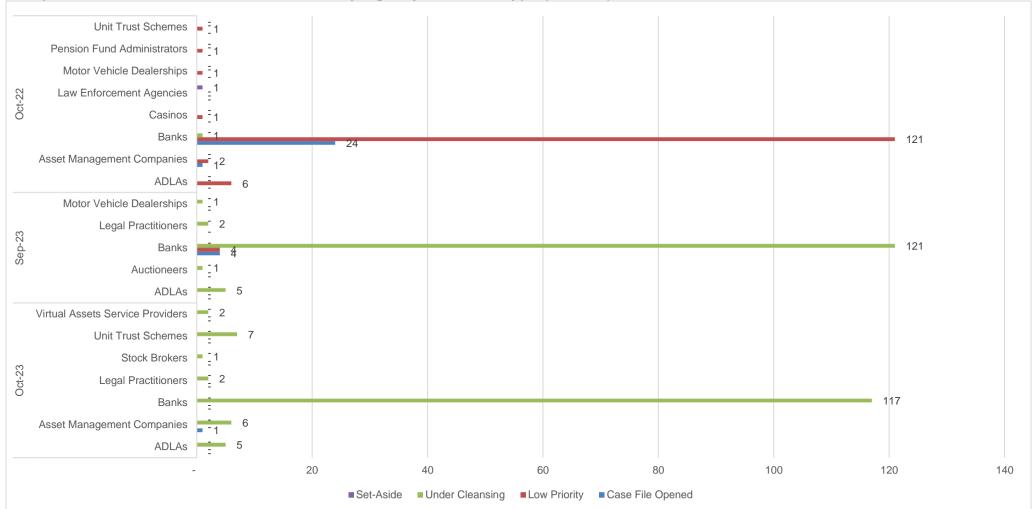

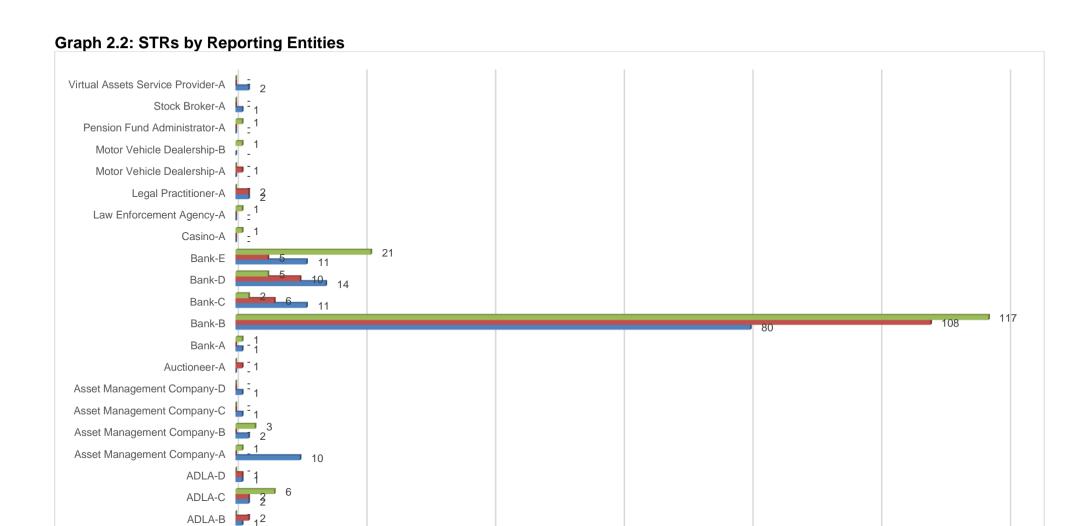

2. Classification of Reports

Graph 2.1: Classification of STRs received by Agency Business Type (Sectors)



The chart above shows that the total number of STRs received during the period under review increased slightly to 141 STRs when compared to 138 STRs recorded in September 2023. Further, from all the STRs received in the period under review, only 1 report was classified as 'high priority' while 140 STRs were still under cleansing at the time of reporting. The banking sector continues to file the most STRs nationally.



In the period under review, Bank-B filed the majority of STRs (76% or 80 STRs).

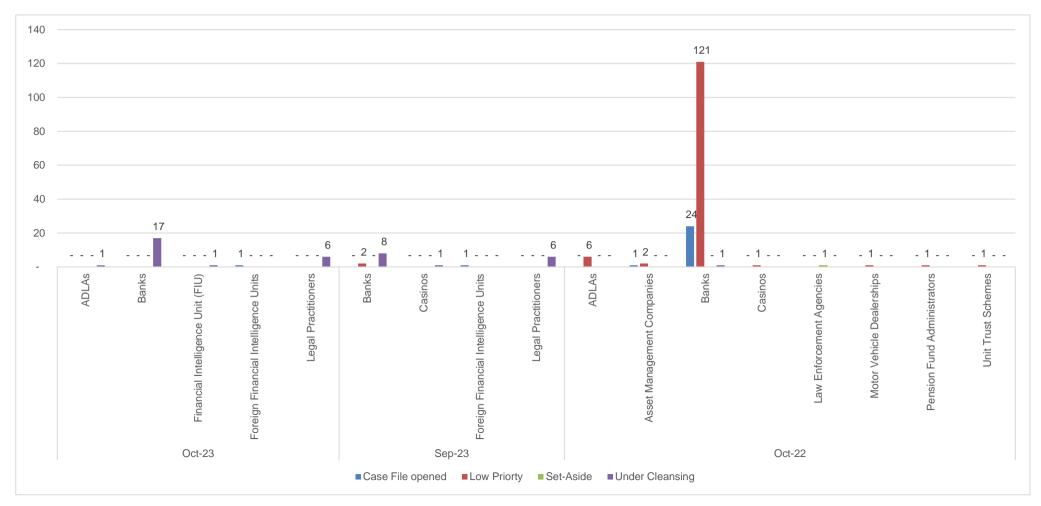

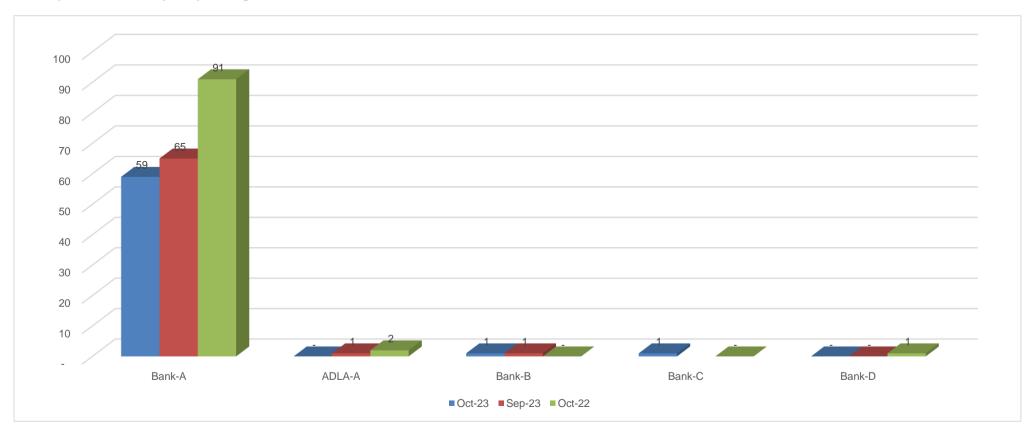

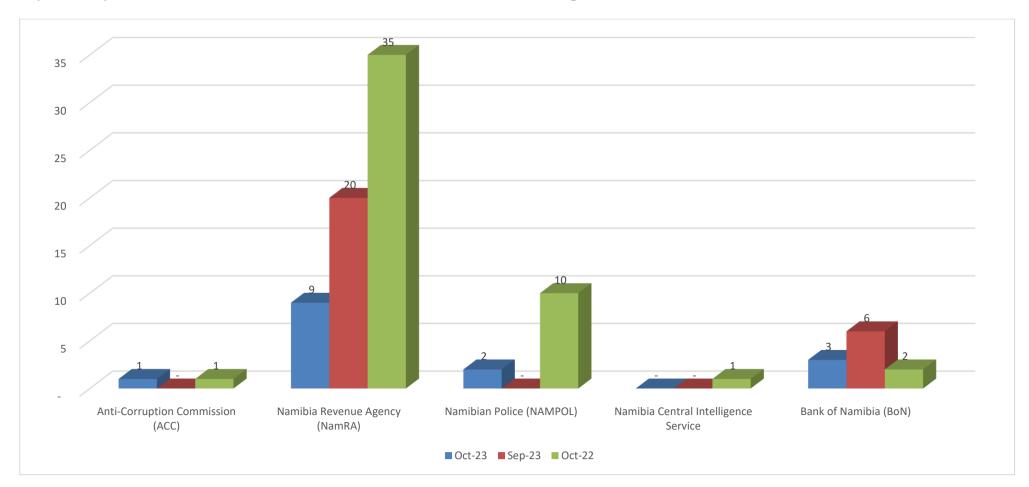

In the period under review, 353 Cases, 508 IRDs and 14 IRIs were still under analysis. To date, the total number of SARs and STRs classified as 'low priority' amounts to 1,031 and 7,765 reports, respectively. This represents 64% and 70% of all the SARs and STRs received by the FIC to date, respectively.

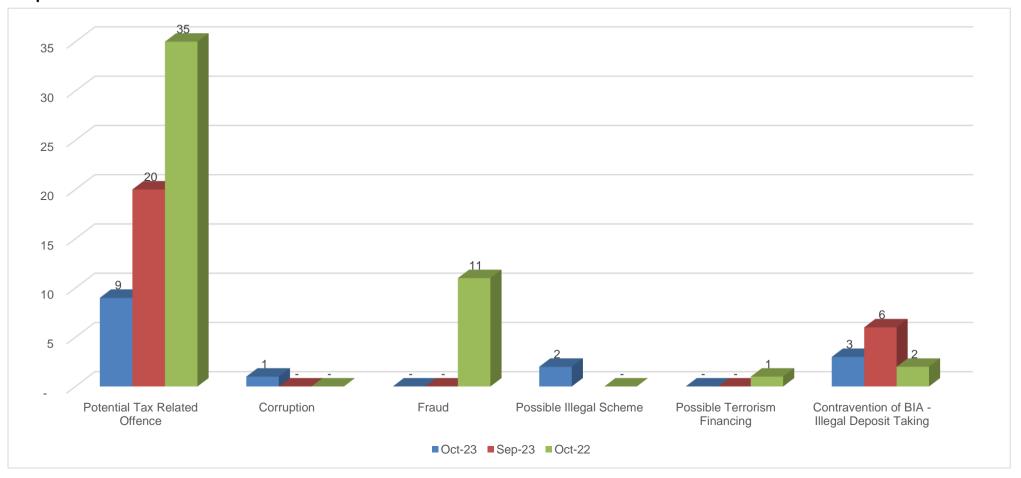
4. Disclosures

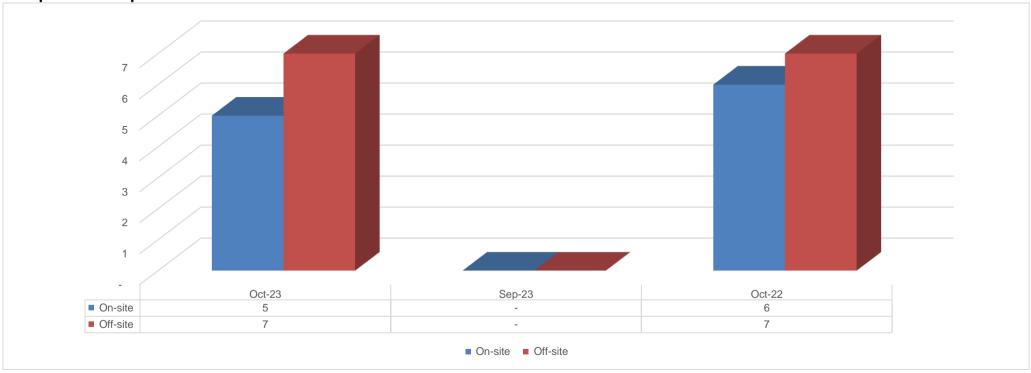

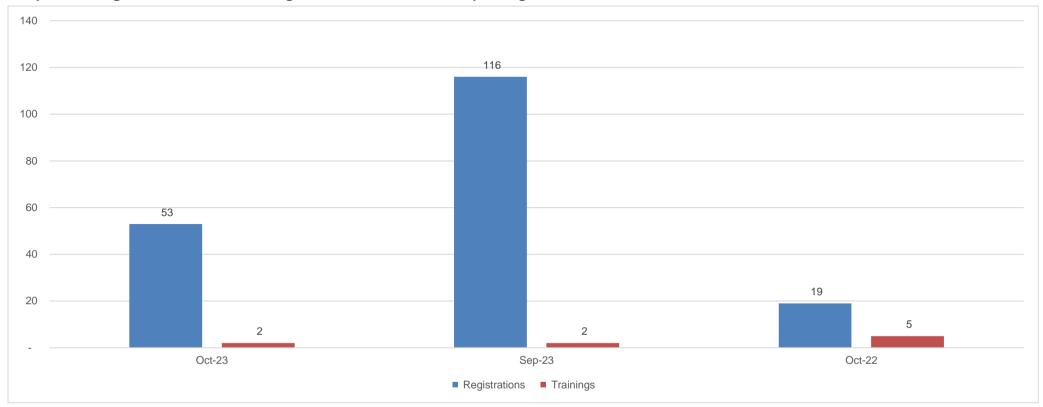
